### Minnesota Division Office Is on the Move

Attending an IWLA National Convention is the highlight of the environmental year! This year's 89th annual event was held July 12-15 at Des Moines, IA. It is a place to learn, network, greet old friends and make new ones, take a look at the big national picture, plan for the future and have fun. Fourteen Minnesota Ikes were part of the yearly gathering, this year celebrating America's Great Rivers and concentrating on the Mississippi and Missouri.

MN Ikes who attended the National Convention included Dwight and Becky Ault, Larry and Nancy Dolphin, Jim and Merlene Stiles (Austin Chapter), Jill Crafton (Bush Lake), Sally Hausken (Prairie Woods), David Hayes (Grand Rapids Wes Libbey), Gary and Cherry Schwartz (Owatonna), Barb Waldron (Cass County) and Dave and Margo Zentner (W. J. McCabe).

Wednesday morning's Keynote Speaker was Daniel M. Ashe, recently confirmed Director of the U.S. Fish and Wildlife Service. Ashe spoke of the challenges facing efforts to preserve and protect fish and wildlife and their habitats in this struggling economy

Committee meetings occupied Ikes in the afternoon. The Parade of States, the Wednesday evening social event of the Convention, found attendees traveling from Division Hospitality Room to room sampling goodies supplied by states. Rootbeer floats, MN Division's perennial offering, was a favorite dessert.

Thursday was filled with the Membership Breakfast, presentations, the Conservation Luncheon, workshops and was topped by a barbecue at the Des Moines Chapter's spacious clubhouse.

At a Friday morning breakfast, hosted by the Midwest Office each member reviewed their program.

**Brad Redlin** spoke about the Farm Bill and Energy Director **Nancy Lange** recounted the need to continue to decommission old coal plants and replace them with cleaner energy sources. **Paul Lepisto** noted that the unprecedented high water on the Missouri River demonstrated the need for changes in policy and practice for farming and water usage. **Gwen Steele** reviewed her role as Administrative Manager. **Eric Jensen** described efforts to transition utilities from "profit to customer service" by a process called decoupling.

Friday morning's Keynote Speaker was Will Dilg Chapter member **Barry Drazkowski**, Director of GeoSpatial Service at Saint Mary's University who presented Will Dilg's River: Change, Restoration and Future. Using photos and slides, he sketched a history of the Mississippi from the 1800s to the present day. He explained that land surfaces around the Mississippi are more than 2,500 years old and that in the 1890s the flood plain was heavily forested. In the steamboat heydays, 1750 acres were cut each day to keep the boats moving. He showed the locks and dams of 1935 that changed the river and added, "Navigation has a big price for little benefit." Efforts at restoration, begun in the 1970s have been successful, but progress has slowed, the result of a sluggish

economy and little political will. According to Drazkowski, "We will never again see Will Dilg's river, but we can protect and restore it."

On Friday, the most important business of the Convention was held. Three resolutions were presented by the Resolutions Committee: Water Quality Trading Programs, Keystone XL Pipeline and Lead Ammunition and Fishing Tackle (sponsored by the Walter J. Breckenridge Chapter and greatly watered down by the Resolutions Committee). All three were passed by delegate vote. The Breckenridge Resolution originally called for phase out of manufacture in five years, sale in ten years and use in fifteen years of lead hunting and fishing equipment. There was considerable discussion and controversy over the resolution because it had been changed by the Resolutions Committee. As a result, Minnesota delegates found it inaccurate, ineffective and no longer in the spirit in which it had been written. An attempt to table the resolution indefinitely by the Minnesota delegation was defeated as was an attempt to further water it down. Eventually it was passed as it came from the Resolutions Committee.

### **National Dues Increase**

With much advanced fanfare, a dues increase of \$4 per member was passed after spirited discussion and a roll call vote and will take effect for 2012. The rates will be:

Individual \$40, Family \$60, Student \$20 and Youth \$8. The cost of a life membership was raised from \$500 to \$1,000 and for a Family Life Benefactor to \$1,500. If you wish to become a life member at the old rates, you must do so before Jan. 1, 2012.

### **Loons of Chik-Wauk**

The loon, our mysterious state bird, was the focus of the summer at Chik-Wauk Museum and Nature Center located near the end of the Gunflint Trail and the new destination for Trail visitors.

Museum directors pondered what would provide a learning experience and attract nature lovers to the museum? Loons! An appealing, hand constructed nest was anchored in the shallow bay below the museum building giving visitors a clear view of the loon habitat. Immediately after the nest was in place a pair chose the reedy artificial island as their nesting site. Museum goers watched as the parents produced two eggs and took turns sitting on them for days. (Loon incubation is usually 27 to 30 days.) Then the ever present predators threatened. When both loons left the nest, an eagle swooped in and destroyed the eggs.

Not to be deterred, the loons tried again, a bit wiser. Museum loon supporters added upright branches to the nest which did deter the watchful eagles. Parents patiently attended the eggs for 27 days and on July 15 and 16 the eggs hatched two soot colored chicks. The mother protectively took the babies on their first swim and dive, keeping close track of her new brood. (We watched the learning ritual through a spotting scope.) While the chicks were on the nest, an eagle flew overhead but the little ones were safe under the mom's wings and the mother let out a stern loon warning. The day was spent teaching the youngsters swimming, diving and other loon skills with each foray taking the family farther from the exposed island nest.

Then the family vanished. As loons do, the mother had taken the chicks to a more protected site. Occasionally on windy days the family appears seeking the shelter of the bay. All ready for next year's nesting, a state of the art nest will replace the old. It is a plastic based structure with space for natural plants to grow and places to add tall protective plants. Hopefully these loons or another pair will become an annual part of Chik-Wauk's nature lore.

### **Great Lakes Issues Report**

The League's Great Lakes Committee continues to be engaged with the threats facing the Great Lakes. The looming threat of Asian Carp entering Lake Michigan from the Mississippi has prompted calls for the Army Corps of Engineers to close the canal entrance at least temporarily if not permanently. Dave Zentner has drafted a letter to John Goss, the Asian Carp Czar for the Obama administration. As committee members have engaged the Corps and other levels of government, it has become apparent that any progress must come from higher levels of government.

Dave Zentner and Jill Crafton have discussed Asian Carp prevention and barrier locations with representatives from other leading conservation organizations and governmental groups to pull together studies and information to guide Corps of Engineers projects.

Ballast Water Treatment is in a holding pattern presently. Threats from legislation to weaken higher state standards are pending. The Division and the Great Lakes Committee signed on to address these threats to states.

The Great Lakes Water Compact. Jill Crafton attended a meeting with the Minnesota DNR, Healing Our Waters members and MEP allies to urge more transparent water conservation policy and implementation development.

The Great Lakes Water Quality Agreement negotiations have been stalled. Members of Great Lakes United are leading the Healing Our Waters effort to monitor the negotiation, participate in comment opportunities on Agreement substance and process.

Following a Saturday morning breakfast, the Directors participated in an intense discussion on pressing topics including issues, organization recognition, fund raising and others. Example. The need to increase fishing and hunting

license fees was not enacted this year but will be necessary within two years. The feeling was that the publicity for the increase was not started early enough to do a good job of public education.

An Ike Blitz is needed to make our name and mission better known and attract interest and active members. Important local issues start new chapters and bring in new members. Division focus on three top issues may concentrate action efforts.

Division funding activities are underway. Gopher Chapter members have been contacted for donations with matching goal of \$500. Downsizing the office space will save \$3,000. President **Larry Dolphin** invited all 18 chapters asking them to hold some kind of chapter activity that could raise \$2-5,000 to be dedicated to the Division. Under the direction of **Ruth Saari**, Minnehaha Chapter will hold their annual silent auction this fall and donate the proceeds to the Division.

Austin Chapter plans a canoe trip with a hamburger cookout. What creative plans will other chapters choose?

Afternoon provided free time to hike, canoe, explore the beautiful grounds and check out the Center's sustainability efforts. Following dinner President Dolphin introduced Ikes to the recently produced film *Green Fire*, a new biography of Aldo Leopold which explores his philosophy of the land and its creatures.

### **Summer BOD Meeting**

Early Sunday morning Ikes met for the Summer Board of Directors' meeting. Reports from Executive Committee, Directors at Large and Committees updated their responsibilities. It is helpful to have natural resources professionals like **Donna Dustin** and **Bill Berg** on hand for current information.

#### **Some Notes:**

Reinvest in Minnesota (RIM) was funded and supporters will be thanked. The State budget bill was resolved with smaller cuts than the original bill.

Dangers to the environment are side effects of hydro fracking (mining with sand blown horizontally to get out oil or natural gas.) Tar sands mining with Keystone XL Pipeline stretching from Canada to Texas can result in possible environmental damage. Our policy against water trading allows us to take action on that topic. GreenStep action in Austin and a McKnight grant was reported by **Michelle Schroeder**. Great Lakes issues were presented by **Jill Crafton**. (See p. 3.) A grant from National IWLA was received to help fund the 2012 Watershed (formerly Wetlands) Summit titled Water Solutions Summit.

DNR moose research was not funded as was other legislation mentioning climate change. A motion was passed to create a sign-on letter endorsing a research proposal with provision that climate change implications are written into the LCCMR U of M research proposal. (The DNR plan for moose management was released on August 15 and open for comment until September 30. See the plan and make comments at www.mndnr.gov/moose/.) Wolf de-listing was discussed. In Minnesota the wolf population is healthy but in the west prejudice against wolves is still strong.

Many thanks to Michelle Schroeder for her dedication to the Division. She had promised to take notes for Secretary Gregg Thompson and expected to be at Deep Portage on Saturday when plans changed. Sunday morning she hopped in her car and beat it up to the meeting from Minneapolis, arriving with lap top in hand just as the meeting began. That's dedication. Donna Dustin volunteered to take notes at future meetings with advance notice to bring her laptop.

July meeting speaker was John Hickman, the executive producer of the documentary "River Revival: Working Together to Save the Minnesota River." In August Laura Van Riper, terrestrial invasive species coordinator for the Ecological and Water Resource Division of the Minnesota DNR presented a program, "Biological Control of Invasive Species."

**Prairie Woods Chapter** will sponsor three events at Detroit Lakes and Moorhead in October featuring Dr. Aaron Bernstein speaking on Sustaining Life: How Human Health Depends on Biodiversity. Bernstein's research illustrates the dependence of human life on biodiversity with an emphasis upon the local wildlife in Detroit Lakes as well as the medical conditions present in those who may attend his lectures.

### **IN MEMORIAM**

From 1978 to 1980 Larry Schultz, a member of Jaques Chapter (then Agassiz Chapter), served as Minnesota Division President. Larry died April 9 and was recognized as a dedicated conservationist.
